

THE CORPORATION OF THE TOWN OF MILTON

BY-LAW NO. 018-2025

BEING A BY-LAW TO EXEMPT CERTAIN LANDS FROM PART LOT CONTROL PURSUANT TO SECTION 50 (7) OF THE *PLANNING ACT*, IN RESPECT OF LANDS DESCRIBED AS BLOCKS 146 AND 151 on R.P. 20M-1263 IN THE TOWN OF MILTON, REGIONAL MUNICIPALITY OF HALTON (MATTAMY (BROWNBRIDGE) HOMES LIMITED) – FILE PLC-01/25

**WHEREAS** Section 50 of the *Planning Act*, R.S.O 1990, c. P.13, as amended, provides that no person shall convey part of any lot within a Plan of Subdivision;

**AND WHEREAS** Section 50(7) of the *Planning Act* provides for a Council to designate by by-law that Section 50 does not apply to certain lands within a registered plan of subdivision;

**AND WHEREAS** the Council of the Corporation of the Town of Milton deems it advisable to enact such a by-law to exempt Blocks 146 and 151; R.P. 20M-1263, from those provisions of the *Planning Act* dealing with part lot control;

**NOW THEREFORE** the Council of the Corporation of the Town of Milton hereby enacts as follows:

1. **THAT** Subsection 5 of Section 50 of the *Planning Act* does not apply to lands described as exempt Blocks 146 and 151; R.P. 20M-1263, and more particularly described in Schedule 'A' attached hereto and forming part of this by-law for the purpose of creating nine (9) townhouse units.
2. **THAT** notwithstanding Section 1 of this by-law, this by-law shall expire 365 days from the passing thereof unless the Council of the Corporation of the Town of Milton has provided an extension by amendment to this by-law prior to its expiry.

## SCHEDULE 'A' TO BY-LAW NO. 018-2025

### Legal Description

**ALL AND SINGULAR** those certain parcels or tracts of land and premises situate, lying and being in the Town of Milton, in the Regional Municipality of Halton in the Province of Ontario and comprising Blocks 146 and 151 on R.P. 20M-1263, and being more particularly described as follows:

All of Block 146, Registered Plan 20M-1263, designated as Parts 1 to 10 inclusive, on Reference Plan 20R-22868.

All of Block 151, Registered Plan 20M-1263, designated as Parts 1 to 17 inclusive, on Reference Plan 20R-22867.
