BY-LAW 029-2025

BEING A BY-LAW TO AMEND THE TOWN OF MILTON COMPREHENSIVE ZONING BY-LAW 016-2014, AS AMENDED, PURSUANT TO SECTION 36 OF THE *PLANNING ACT* IN RESPECT OF THE LANDS DESCRIBED AS PART OF LOT 7, CONCESSION 5, FORMER GEOGRAPHIC TOWNSHIP OF TRAFALGAR, TOWN OF MILTON, REGIONAL MUNICIPALITY OF HALTON (MATTAMY (BROWNRIDGE) LIMITED) - FILE: Z-25/24

WHEREAS pursuant to Section 36 of the Planning Act, R.S.O. 1990, c.P.13, as amended, the Council of a local municipality may enact a by-law to remove a holding provisions;

AND WHEREAS the Council of The Corporation of the Town of Milton has delegated approval authority of this By-law to the Commissioner, Development Services, pursuant to Section 39.2 of the Planning Act, R.S.O. 1990, c.P.13, as amended, to approve the removal of a holding provision from zoning by-laws;

AND WHEREAS notice of intention to remove the Holding (H58), (H59) and (H63) Symbols have been provided in accordance with the regulations of the Planning Act, R.S.O 1990, C.P.13, as amended;

AND WHEREAS it has been confirmed to the Commissioner, Development Services of The Corporation of the Town of Milton that all of the necessary conditions required for the removal of the holding provision have been satisfied;

AND WHEREAS the Commissioner, Development Services of The Corporation of the Town of Milton deems it appropriate to remove the Holding (H58), (H59) and (H63) Symbols on the lands;

NOW THEREFORE the Commissioner, Development Services of The Corporation of the Town of Milton hereby enacts as follows:

- THAT Schedule A to Comprehensive Zoning By-law 016-2014, as amended, is hereby further amended by changing the existing site-specific Residential Medium Density 1 (RMD1*315-H58), Residential Medium Density 1 (RMD1*315- H59) and Residential Medium Density 1 (RMD1*315-H63) zones to a site-specific Residential Medium Density 1 (RMD1*315) Zone Symbol on the lands shown on Schedule "A" attached hereto.
- 2. **THAT** Section 13.2 is amended by adding the date that the holding provision applicable to Section 13.2.1.101, Section 13.2.102 and Section 13.2.106 is lifted on the lands.
- 3. **THAT** this by-law shall come into force and effect on the day of its passing.


