

THE CORPORATION OF THE TOWN OF MILTON

BY-LAW NO. 030-2025

BEING A BY-LAW TO AMEND BY-LAW NO. 1984-1, AS AMENDED, BEING A BY-LAW TO REGULATE TRAFFIC AND PARKING ON HIGHWAYS UNDER THE JURISDICTION OF THE TOWN OF MILTON

WHEREAS the Council of the Corporation of the Town of Milton deems it expedient to amend By-law No. 1984-1, as amended, being a By-law to regulate traffic and parking on highways under the jurisdiction of the Town of Milton;

NOW THEREFORE the Council of the Corporation of the Town of Milton hereby enacts as follows:

1. **THAT** Schedule 1, Section 5 (3) – NO PARKING AT ANYTIME – SIGNS ON DISPLAY to By-law No. 1984-1 is amended as described in Schedule “A” to this By-law;
2. **THAT** Schedule 3, Section 5 (4)(b) – NO PARKING FOR RESTRICTED TIMES – SIGNS ON DISPLAY to By-law No. 1984-1 is amended as described in Schedule “B” to this By-law;
3. **THAT** Schedule 16, Section 9 (1)(a) – U-TURNS – SIGNS ON DISPLAY to By-law No. 1984-1 is as amended as described in Schedule “C” to this By-law;
4. **THAT** Schedule 34, Section 11 (3) – CYCLE LANES – SIGNS, ETC ON DISPLAY to By-law No. 1984-1 is as amended as described in Schedule “D” to this By-law;
5. **THAT** Schedule 34, Section 11 (3) – CYCLE LANES – SIGNS, ETC ON DISPLAY to By-law No. 1984-1 is as amended as described in Schedule “E” to this By-law;
6. **AND THAT** this By-law shall come into full force and effect when the appropriate signs have been erected and are on display.
7. **AND FURTHER THAT** all other provisions of By-law No. 1984-1, as amended, remain in full force and effect.
